



Work Requirements for Club Members

- A “Canine Credit” shall be equivalent to 15 minutes worked at a Club event.
- Club members shall be required to work 10 hours (equivalent to 40 Canine Credits) at CCDAC events during the calendar year.
- Club members are responsible for completing and turning in worker sheet(s) for the class(es) or time(s) worked during the trial.
- Time worked will be computed based on the length of a class according to the Class Start and Class Finish times on the USDAA recording or AKC Summary sheets.
- Time worked will be rounded up to the nearest quarter-hour.
- For the purposes of calculating credits “per class” for USDAA trials, a class will consist of the Championship class and the corresponding Performance class. For AKC events, a class will consist of the regular class and the corresponding Preferred class. (For example, Masters Gamblers and P3 Gamblers count as a single class.)
- The Trial Chairman or Secretary shall fulfill their annual requirement for the year. However, they shall not receive Canine Credits since both are paid positions.
- Course Builders will earn 2 credits per class.
- The Awards coordinator(s) will earn 8 credits per trial.
- Chief Course Builders (no more than one per ring) will earn 4 credits per class.
- Chief Ring Stewards (no more than one per ring) will earn 4 credits per class.
- Chief Scorekeepers (no more than one per ring) will earn 5 credits per day per ring, in addition to actual time worked.
- Members who help set-up or take-down before and after the trial will earn credits based on time worked if he/she has worked more than 15 minutes.

- Credits earned above the minimum requirement can be used towards future CCDAC membership renewal and for entry fees at CCDAC events based on the table below. These may not be used until the following membership year.

The Definition of a Free Entry for the purposes of the Worker Requirements and Benefits is **“One free entry for one dog for one day of a trial, not including Tournament Classes (for USDAA)”**. Additionally, the Trial Chairman for an event will be paid the equivalent of his/her entitled benefit, since this position already receives free entries into that event.

- Benefits shall be used, by a current Member, within two years following the end of the year in which they are earned, or they will be forfeited.
- Members earning free Membership for the following year will automatically have that benefit applied.
- Other definitions will be defined as needed.
